GENERAL PRINCIPLES

- All surface waters and groundwaters are public and are a resource that must be preserved and be used in accordance with criteria of solidarity.
- Uses of water are directed at water conservation and the preservation of the quality of the resource
- The use of water for human consumption is a priority







MAIN POINTS

- The management of water resources must be undertaken by a single entity for the collection of service / supply, sewage and water treatment.
- No more municipal administration, but transition to a superstructure (division into Optimal Territorial Areas - OTA)
- Identification of the Authority that oversees OTA
- Locating Manager of the Integrated water system.
- Cover the costs of the system through rate

AREA PLAN

- Central document of the contractual relationship between manager and O.T.A. is the Area Plan, which also contains the investment plan and the tariff rate
- The determination of the tariff rate is based on the costs of maintenance and planned investments, and it has to ensure the full economic coverage of the service







THE TARIFF

The tariff, collected directly by the operator, must cover all costs of the service:

- collecting water: water quality must be guaranteed within defined standards;
- distribution: the losses must be reduced (physical or administrative) for the efficiency of the system;
- depuration: throughout the area served by the distribution must be connected to a sewage treatment plant, which must guarantee the quality of re-entry







THE MISSION OF THE PUBLIC AUTHORITY

- Always protect the water resource
- Ensure compliance with the Plan area and the contract
- Intervene with specific actions to hold rates and financial support for emergency situations

- ➤ Regional Council Decree 836 of 03.11.2009 Extraordinary Plan of reorganization of river, lake and sea resources. Integration of the group of projects approved by Regional Council Decree 668/2007 and identification of priority interventions.
